Mr. English and Mr. Greenstein reviewed the Minimum Municipal Obligation requirements by the Commonwealth's Auditor General each year. There were no questions by Council and Mr. English signed off that this document was presented to Council.

Mr. English stated the old Trash Truck that is used for Bulk Trash needs to be repaired. The cost would be roughly \$80,000.00. The cost of a new truck will be significantly higher. I will get back to Council with the final cost.

## **COMMITTEE, DEPARTMENT, AND MAYOR'S REPORT**

Mayor Fouriner stated the newsletter is online and has been mailed. There will be the 9-11 ceremony this Friday at Borough Hall. Robyn Dronitsky is coordinating an event at MacKenzie Park for the children to make signs of support that will be placed throughout the Borough. Once again, Janeway Towing will be generously giving away bicycles to the children.

We are working on details of still having a Halloween Parade but it will be different this year. I will be updating the community as we go forward.

Mr. Borgerson asked if Mr. Frankenfield had any items from the Fire Company that he wished to report.

Mr. Frankenfield stated that Council has received the report and asked if anyone had questions. No questions were posed.

Mr. Bergerson praised the volunteers of the Fire Company and all the work they do for the Community. He reminded everyone that volunteers are needed at George Clay.

Chief Sinclair stated Council has a copy of my report. I am asking Council if I can continue looking for part-time officers. The Borough has only one crossing guard on duty, Sue Defuso, who is doing a phenomenal job for the schools that are currently holding in person class.

## **PROFESSIONAL REPORTS**

Mr. Hassan stated that his report in the Council's packet. Update to Balligomingo Road has been substantially finished. In the next week or the week after here will be a final walk through. Pertaining to the detour even through the project is going to be even though the project is deemed complete. The agreement between PADot and 14 Union Ave extension until January regarding the change approvals for Union Hill to get the retaining wall in place.

Mr. Hassan stated that 8 Merion Avenue parking lot discussed with the parking committee there is notice to proceed. The project is scheduled to be completed before the next meeting on permit parking. We will make sure that the project is completed as the Council has envisioned it.

The next matter is MacKenzie Park updates. There is proposal in front of Council to authorize a topographic survey for the entire park property. We are asking for guidance from the Council to move forward to prepare a plan to update and remodel the park. The Council members had a lengthy discussion regarding improvements done in phases, obtaining grants and reaching out to local business for funds.

## **NEW BUSINESS**

Mr. Borgerson asked if the November Election will be held at St Gert's church.

Mr. English stated that the St. Gert's will be the polling place in the Borough. The building is being cleaned and any repairs needed are being taken care of.

Mr. Bergerson stated that the police dog Office Jaxx is being retired. For everyone's clarification what purpose does the dog serve for our community?

Chief Sinclair stated the Borough has had several police dogs. Office Jaxx is 7 years old and that is the average time for a canine officer. The main purpose for the dog is a supplement to our officers and is used in searches for drug, finding persons and also used for helping other departments with mutual aid. Also he is a great ambassador at Borough events.

Mr. Gonzalez asked questions regarding the cost of care of the dog as well as training.

Chief Sinclair answered Mr. Gonzalez questions.

The Council members had a discussion regarding the benefits of having a dog and how having a canine officer is an asset to the community.

Mr. Bergerson asked what action item from Council to need to fund the dog. What would be the cost of continuing to have a new canine officer.

Chief Sinclair stated that the additional cost of \$9,000.00 would be added to the budget.

Mr. Blumenthal asked if the dog stays with his trainer at all times and what other municipalities have canine officers that we share our canine with.

Chief Sinclair stated that Plymouth Meeting Township, Whitmarsh Township and Upper Merion Township all have canine officers.

Mr. Bergerson asked for a motion for additional funding for the police dog.

Mr. Beck asked Mr. Hassan about PennDot has given 14 Union Hill a deadline to finish the work at the top of Balligomino Road.

Mr. Hassan stated that the deadline is January 31, 2021. PennDot has made it perfectly clear that no further extension would be given.

Pat Zapien, 247 Moir Ave, stated that there is one opening for a polling person to work on Election Day. It is a very long day. Pat asked that if anyone was interested to reach out to the Borough and Mike English could forward the names to her.

Due to Covid-19 Recreation programs had to be cancelled this year but the Recreation Committee would like to help Danelle with the Halloween events. She spoke about the Children's and Senior Christmas parties and asked if anyone who would like to help out the Recreation Council.

Mr. David Frankenfield stated that Fire Protection Week will be next month. The Fire Company will work out some way to visually provide information in place of the Open House. The Fire Truck will be riding through the community for Halloween. In regard to the survey of MacKenzie Park, the Borough needs to make sure to define the Borough property and what is the private property.
