## **BOROUGH MANAGERS REPORT**

Mr. English indicated that his report is in the packet. Council has been asking for vacancies and the alternate members for Planning Commission would have to be done per ordinance. This was verified by Borough Solicitor. Aqua is moving along with the water main replacement for Matsonford Road. Matsonford Road will be repayed late summer early fall.

## COMMITTEE, DEPARTMENT AND MAYOR'S REPORT

Stephen Blumenthal indicated that Public Safety has no meetings for July and will be finalizing an agenda. Safety measures for 4<sup>th</sup> of July are in place.

Mr. Gonzalez had nothing to report.

Tara Gorney indicates that Parking and Traffic Committee meetings are quarterly, and Tara indicated that adaptive signaling was supposed to be in effect in June. Brian Keaveney indicated PennDOT owns traffic signals and the adaptive signaling will take approximately be 4-6 weeks to go live. Tara asked about the parking proposal on Apple Street. Fire Department is still reviewing. Kelli Scarlett will be at the Public Safety Meeting and Mr. Blumenthal will follow up with Tara Gorney.

Mayor Danelle Fournier spoke of the firework watch party. Mayor spoke of a possible shredding event and would like to get other estimates and see the interest in the community. Mr. English suggested possibly doing in the one of the parking lots of commercial buildings due to traffic control and timing in September. Mr. Carfagno indicated JP Mascaro might be worth looking into. Mr. Blumenthal spoke also about the shredding event.

Sal Carfagno spoke of National Night Out on August 2<sup>nd</sup>, working with Public Safety Committee and budget. Sal Carfagno spoke of Dan Webster and Officer Lolli who assisted in a raid in Philadelphia and was able to assist in the recovery of drug paraphernalia, weapons and arrests.

Dave Frankenfield indicated that report is in the drop box. Mr. Frankenfield spoke of upcoming events, Meet and Greet, July 27<sup>th</sup> will be at MacKenzie Park, boat training at the River. Mr. Frankenfield also commented on the work by Public Works on tree trimming in the Borough.

Guy Davis indicated that the PC met on the 7<sup>th</sup> and they discussed 411 Swedeland Road. Also discussed was Shade Tree Commission and review list of approved trees. Pennoni indicated there was no updates on the Grants. Planning Commission has received zoning maps and committee is looking into a towne center.

Mr. Borgerson asked for Nominations. Steven Blumenthal nominated Jeffrey Ewing, Richard Greenstein nominated Maxine Denker, Tara Gorney nominated Kelly Snizavich. A roll call vote took place with Stephen Blumenthal voting for Jeffrey Ewing, Tori Conicello Emery voting for Jeffrey Ewing, Jose Gonzalez voting for Jeffrey Ewing, Richard Greenstein voting for Maxine Denker, Tara Gorney voting for Kelly Snizavich and Douglas Borgerson voting for Jeffrey Ewing.

Resolution 2022-15 was adopted, Jeff Ewing was sworn in and Mr. Ewing took seat.
