Mr. English indicated that his report is in the packet. Road program began August 8th and with milling and repaving. Mr. Hassan indicated that the paving should be completed next week. PennDOT will be repaving Matsonford Road in September/October. Mr. Greenstein commented on the work completed at Spring Mill Road and Conshohocken State Road.

COMMITTEE, DEPARTMENT AND MAYOR'S REPORT

Stephen Blumenthal indicated a new date will be assigned as a new chair is appointed. Mr. Blumenthal thanked all public safety teams for a successful National Night Out.

Mr. Hassan provided an update on Open Space Committee- Mr. Hassan indicated that one of the grants was secured out of the three grants that were applied for.

Tara Gorney indicates that the next Meeting is September 7th. All open action items will be discussed. Ms. Gorney indicated that the public should reach out with any concerns.

Sal Carfagno thanked all businesses that donated to National Night Out and all safety teams and public that came out and assisted in making it a successful night. August 20th will be Community Day at MacKenzie Park and the 9/11 Ceremony will take place at Borough Hall on September 11th at 7:00pm. Mr. Carfagno updated the public about the shooting that took place in the Borough. It was an isolated incident, and the victim is home recovering. The suspect is being held at Montgomery County Correctional Facility.

Dave Frankenfield indicated that George Clay will be at Community Day and Fire Company meeting is report is the first Tuesday of the month and commented on the successful National Night Out. Meet and Greet will be Sunday, August 28th from 11am to 2pm. No questions were presented

Guy Davis discussed the Planning Commission meeting and indicated that PC Members voted unanimously to obtain a professional planning service to address the Towne Center. Richard Greenstein indicated that the Towne Center was also discussed and happy that there is movement from the PC in moving forward. Tara Gorney asked Mr. Iannozzi what the process of the next steps would be. Mr. Iannozzi indicated that there is no need to go to bid. No other questions were presented

PROFESSIONAL REPORTS

1. John Iannozzi, Esq indicated that there is a zoning advisory for 946 Matsonford Road. Applicant is asking for special use to use the property as a residence/dog boarding. Mr. Iannozzi suggests that Borough stay neutral and let the ZHB members decide.

Mr. Iannozzi indicated that there is an enforcement agreement for 24/26 Portland Road. The property is currently being used as a yoga/inquirer and bringing the building up to Borough Code. Mr. Blumenthal asked for a motion to approve the Enforcement Agreement.

Mr. Gleba discussed the DEP report and Mr. Gleba asked for a breakdown of the bills/expenses and pensions. Mr. Hassan addressed Mr. Gleba's concerns regarding the removal of trees. Mr. Hassan discussed the Department of Agriculture and Montgomery County Conservation District which reported damaged trees at MacKenzie Park, Elizabeth Street and Balligomingo. Mr. Gleba requested more time to speak and Mr. Blumenthal asked for a motion to allow Mr. Gleba more time. No motion was made therefore Mr. Gleba's time has expired.

Guy Davis, 28 Balligomingo discussed a court case regarding issues about residents at public meetings stating their address and suggested the Borough Solicitor look into this.
