Dave Frankenfield indicated that Joe Catagnus and Tina Reese were out in Texas for ESO training and members of the Fire Company will also be participating in elevator training rescue. Mr. Frankenfield also discussed the Easter Breakfast, assisting in the fire in Bridgeport and Fire Company is always looking for more volunteers.

Guy Davis reported that at the last Planning Commission meeting it was unanimously voted to recommend approval to the Council to approve the Vision Plan.

Mr. Blumenthal read aloud Mr. English report which indicated that the CBDG application was submitted on April 7, 2023. 6 resumes were received for the Borough Manager and discussions of next steps will begin. PennDOT repaving was scheduled for Spring/Summer. DCED is still completing this review. Mr. Hassan will discuss the Aqua Main replacement project in his report
- B. John Iannozzi, Esq has nothing to report.
- C. Mr. Khal Hassan indicated that a copy of his report is in the packet.

Mr. Hassan wanted to update on the Aqua project to begin around April 24<sup>th</sup> and will last approximately 5 months. This work is scheduled during the day except for the intersection of Matsonford and Rt 23 which work will take place at night. A press release was issued on April 5, 2023 and further information will be provided as needed.

Mr. Hassan also discussed the install of 33 ADA ramps that will be completed within the Borough at numerous intersections.

Mr. Hassan discussed the resolution before Council this evening 2023-07 which is to adopt the Vision Plan dated March 2023. Mr. Blumenthal asked for a motion to approve the resolution. Mr. Hassan indicated that the repaving on Bullock is on the schedule for 2024 and discussions took place regarding the research of lighting/parking.

(First name inaudible) Slater, resident, had printouts and wanted to discuss the speed limits around St. Gerts park and different roads. Mr. Blumenthal indicated that this should be brought up at the Public Safety and traffic committee meeting.

David Frankenfield, resident, discussed the sink hole on Barr Harbor and also discussed the code red system is not utilized. Mr. Frankenfield indicated that downed trees and road closures should be announced through code red.

**II. COMMITTEE REPORT: PUBLIC SAFETY, TRAFFIC, AND PARKING**

Traffic & Parking:

Update from Aqua regarding Front Street project currently cancelled and pushed to 2029.

Update from PennDOT regarding Matsonford Road paving set to begin on May 1, 2023 overnight. This project has started as expected.

Discussion regarding parking issues on Ford Street including issues with Ford Street/Matsonford parking lot. Traffic Engineer is looking into potential options and will provide the same when available. Update provided regarding Apple Street line painting set to begin as soon as conditions allow (no rain with temps above 70 degrees ideal for line painting).

Discussion regarding Merion Avenue. Traffic Engineer reviewed stop sign requests regarding George Street intersection and agreed a stop sign would be warranted at that intersection as well as George Street and Veteran's Avenue. Resident raised speeding concerns near playground on Merion. Will evaluate for issues and potential options.

Discussion regarding Spring Garden/Spruce/Merion Lane. Traffic Engineer evaluated and does not believe an additional stop sign is necessary because the other area intersections do have stop signs. Investigated into accidents and identified only 1 accident in that location since 2000 which would not have been prevented with a stop sign.

Discussion regarding intersection at Crawford (23)/Moorehead/Spring Garden. Prior meeting with PennDOT suggested they would assist with the intersection potentially including don't block the box lines. Traffic Engineer is looking into current plan and whether the borough can take action in the meantime while waiting for PennDOT.



Police Department:

Upcoming Community Events – Coffee with the Cops @ 9am at Borough Hall

Update on Policy & Procedure Manual – this is now very close to being finalized and is the last piece of the work following the DCED study.

George Clay Fire Company:

Update on DCED Report – Borough Manager spoke with Bob Hedden who believes a drafted report will be available late May/early June. He received the data needed and is now working on the recommendations based on the data.

Update on change to ESO – Technical problems have continued but there is confidence in the company that they are working to fix the issues. George Clay members attended a conference/workshop where they were able to express concerns and hear that they are working to resolve the known issues.

Hi Cristina,  
Below is my consent agenda report.

The OpenSpace committee was held on 3 May 2023. In attendance were myself, Tara Gorney and Khal Hassan. Apologies were provided by Tori Conicello-Emery and Zac Nelson.

The meeting focused on two topics: the official Map for West Conshohocken and the Mackenzie Park Project.

The Intent of the Official Map is to be used as a planning tool to visually identify the goals of the Borough Vision Plan. The official map will be reviewed by the planning commission at their next meeting and will also discussed at an upcoming council meeting. Our goal is to review this with council at the June 2023 council meeting. As part of that review, the Borough Solicitor will advise on the next steps of the process.

DCNR has provided approval for the Borough to progress with Phase 1 of the Mackenzie Park project. Phase 1 will commence post the conclusion of the Summer Program and is therefore estimated to begin early to mid-August with completion before end of 2023. Storm water management will now be addressed in Phase 2 of the project. The Borough will be submitting grants for financial support of Phase 2 of the Mackenzie park project. The Borough Engineer is finalizing the estimates and plans required for grant submission. Submission for Phase 2 grants will be reviewed at the 9 May Council meeting.

Dates for the next open space committee will be available on the official Borough website.

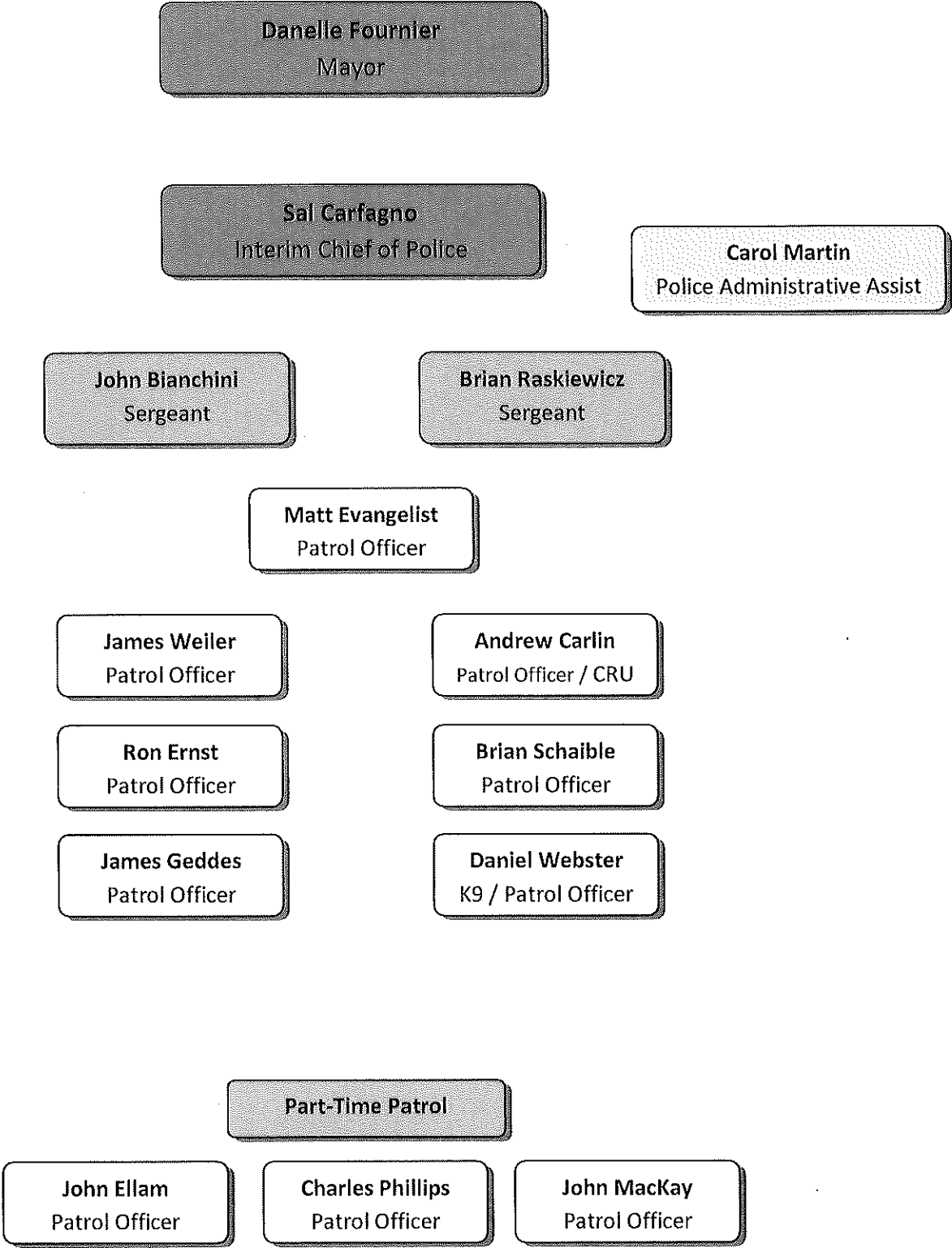

#### **\*\*\* Special Announcement Permit Parking Lot 8 Merion Avenue \*\*\***

The Police Department would like to inform the Public that the Borough's Merion Avenue Permit Parking Lot is no longer a "Pilot Program" and is transitioning to Official Use. New Registrations for residents and business owners interested in applying for Permit Parking at the Merion Avenue Parking Lot can do so at the West Conshohocken Police Department. The applicant must be a resident or business owner, must provide proof of residence or business ownership in the form of a photo identification card and a utility bill. Permits are limited to one per resident or business and one vehicle per resident or business. A \$25.00 registration fee is required each year to obtain a permit.

Once the transition to Official Use is completed, residents will receive instructions on how to renew their current parking permits.

Officers continue to monitor and enforce all parking complaints, issues and concerns throughout the Borough. Residents and businesses are encouraged to contact the Police Department to report any parking complaints or concerns to address them immediately.

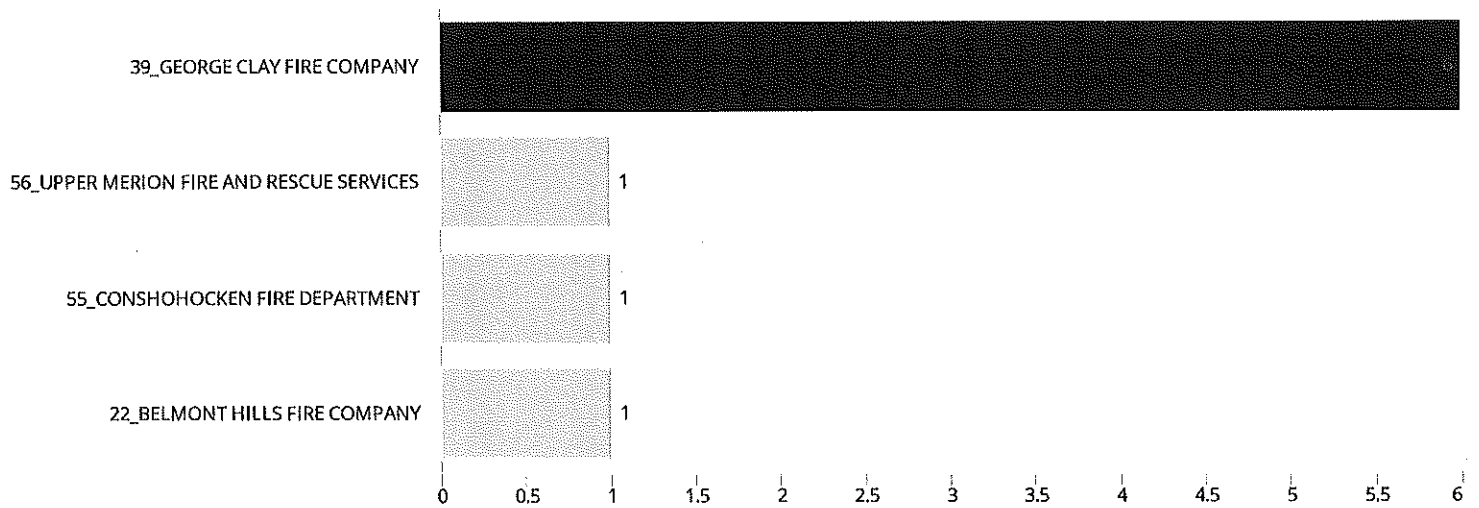

Count of Incidents by District

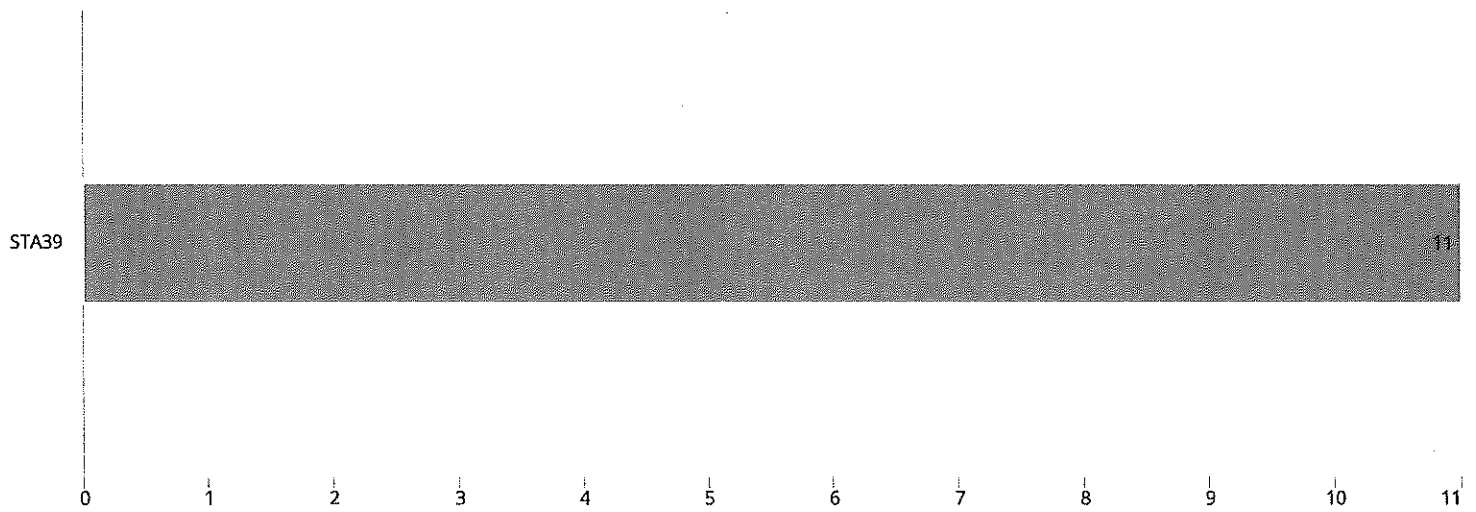

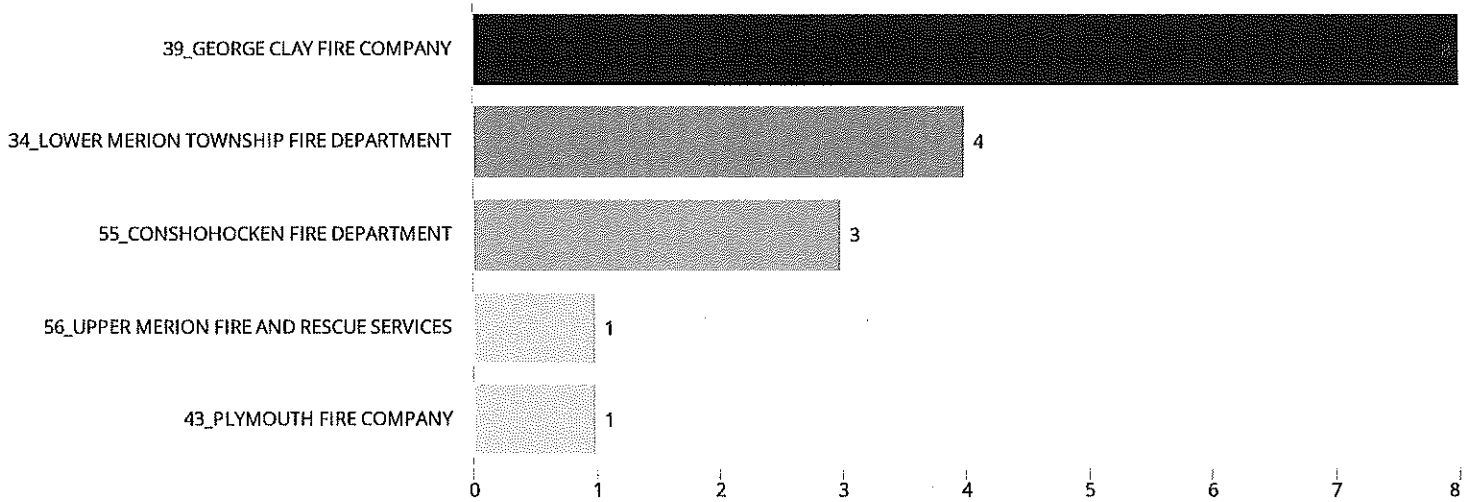

Count of Incidents by District

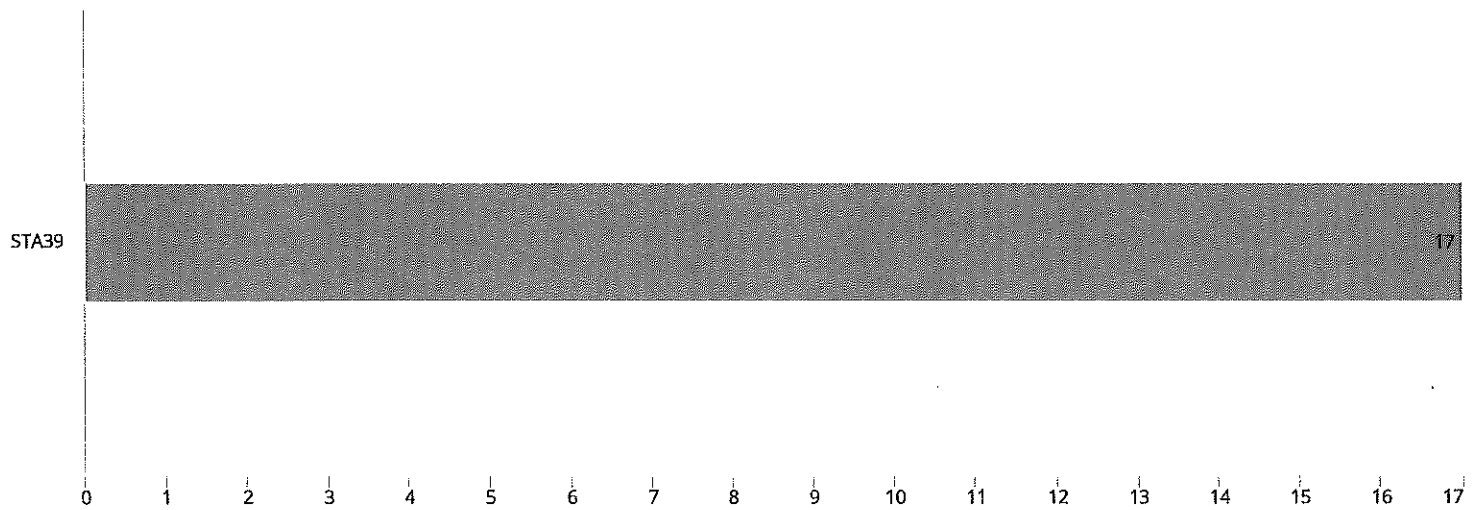
