Mr. Khal Hassan indicated that his report is in his packet. Mr. Hassan indicated that a Notice to Proceed for MacKenzie park was issued on January 4, 2024, Erosion and Sediment Control was installed on February 5th. Demo was postponed to February 14th. Mr. Hassan clarified that the field lighting will be installed during Phase I, as this is soft lighting and will be shielded from residential properties. Phase II grant was submitted for a total amount of \$922,420 for LSA and does not required local matching and will cover the basketball courts and part of the trail as well as other improvements. Mr. Hassan indicated that there is a pending grant, which Resolution is before Council this evening, is MontCo 2040 resolution for 100,000 and percentage is required to match and DCNR for concession and restroom\$250,000. Mr. Hassan provided an update on the Barr Harbor sink hole and states that there is no issue. There is a curb that had settled and will be handled when the weather gets warmer. Walter Gleba, resident was concerned about the new fence at St.Gerts Park. He indicated that prior was a chain link fence and Mr. Ewing indicated that there was no chain link fence prior to new fence being installed. Mr Gleba was concerned about safety and asked if it was a possibility of putting netting to reduce any children trying to leave the area. Mr. Gleba asked about the hours of the lights and Mr. Hassan indicated that the lights will be on from dusk til dawn.

Guy Davis, resident, wanted to incorporate the oldest resolution to the 150th. Mr. Davis also wanted to know what the issue was with the old fence at St. Gert's park. Mr. English indicated that public works noticed that the posts were rotted and due to the construction at MacKenzie that they know that St. Gerts park will be utilized even more.

Jason Saro, resident, wanted to address the blue matting at St. Gerts park being a trip hazard and asked Council to look into this.

Dave Frankenfield, thanked the streets department for the maintenance of the Borough during the snow. Mr. Frankenfield provided background on the lighting at the park which helped the Borough reduce the crime in the Borough. Mr. Frankenfield spoke of the fire that took place in Norristown to which George Clay was called to assist.

We opened the meeting by reminding everyone of the upcoming Spaghetti Dinner at George Clay on Sunday, February 25.

- Fire Marshall's Update:
 - The Marriott is finally installing the fire pump, and should be done by the weekend of February
 16.
 - Inspections should be online in ESO starting next week
 - o The Fire Appeals Board list was sent to Council for approval
- Code Inspector's Update:
 - The tip of the week will be rolling out shortly on the West Conshy Borough's Facebook page
- Traffic Engineer's Update:
 - Montgomery County is asking for transportation and safety initiatives, which are due March 1.
 Some of the initiatives we are proposing, from the vision plan, include:
 - Improving roadway network, reducing cut through traffic
 - Merion Avenue pedestrian improvements
 - Pedestrian crossing over the bridge, potentially a secondary pedestrian bridge
 - Pedestrian bridge from Front to Fayette
 - 76 ramp changes (using Woodmont/Crawford)
 - Widening the road by Wawa
 - 476 ramp additions
- Public Comment on Agenda Items:
 - Dave Frankenfield would love to see informational signs getting off major roadways proposing alternate routes, as well as potential gates to close off on-ramps in the event of traffic incidents. In addition, it would be great to see another bus stop that connects to the R100 line
 - Tina Reese we could potentially apply to remove the borough from Waze app to cut down on through traffic
 - Jay Soppick would like a print out of the Fire Appeals Board ordinance. He also asked the following questions:
 - Do we already have an appeals board?
 - Is the Fire Marshall an employee? Has she been sworn in?
 - Is the code part of the construction code or the whole state code?
 - Are the Fire Marshalls doing their reports here or at Council meetings?

- Why did the fire pump for the hotel take so long?
- Did we ever think about Old Woodmont to Bridgeport rather than widening Front Street?

• Police Department Update:

- Oral interviews have been completed, and there are four candidates remaining. They will complete the full application to allow us to run background checks and complete polygraphs.
 The timeline for hire is looking to be April.
- The next Consortium test is March/April should we need more applicants, we have already registered just in case.
- e-Tickets are all set up, waiting for approval from the courts system which might take several months due to backups. Once it is up and running they will have a website with all ticket records.

• Fire Department Update:

- Lots of marine unit training is underway, they will be operational within the next 2 months
- o They are completing inter-agency training with Gladwyne on Wednesday/Saturday next week
- They will be enrolling in the state class for Fish and Boat, September to November

Public Comment:

- Dave Frankenfield Is there an update on the task force? (We spoke with DCED and are waiting on next steps.) The Appeals Board agenda item seemed out of the blue, how was it appointed?
- o Walter Gleba The park lighting for Mackenzie was never on the development plan, and it came as a surprise. He also does not see the point of it if the park is open dawn to dusk. He filed a RTK last year to see who was asking for lights but didn't receive any names from it. He does not feel that there was input from residents on the lighting, and thinks the lighting will cause trouble in the park. He would like us to take this feedback to Council.
- o Guy Davis How can we prep our police in case there's an influx in crime related incidents?
- o Dennis Frankenfield Can we fix the PA system for meetings? (Yes, it is happening soon!)



FLEET MANAGEMENT

Police Vehicles

Fleet Management Officers maintain all Police vehicle maintenance records.

Records are stored in the Departments web based Fleet Management / GPS System. The system alerts Officers of upcoming vehicle maintenance.

Vehicle Maintenance

Fleet Management maintains the Departments vehicles preventing the need for new vehicle purchases. To keep combat wear and tear and keep vehicles looking new, the Department's vehicles have been re-decaled and changed from black & white vehicles to all black to give them a new clean look.

TRAFFIC & PARKING

Digital Ticket Devices

The Police Department purchased three (3) new handheld portable ticket Devices from T2 Systems. These wireless devices are the latest technology used for issuing tickets. The devices are linked directly to the local court system, send the information electronically and eliminate the need for paper tickets. The Department received approval from the Administrative Office of Pennsylvania Courts to move forward with setting up our system. Training on the devices and website used to store traffic data is scheduled for April.

<u>Traffic</u>

The Police Department continues monitoring all of the Borough's traffic areas and any requests by residents for problem traffic areas. Officers conduct daily traffic details throughout the Borough. Please contact the Police Department to report any traffic complaints or concerns.

Permit Parking

Parking permits or renewals can be purchased at the West Conshohocken

Police Department, Monday through Friday between 8:00am-4:00pm. Applicants must be a resident or business owner, must provide proof of residence or business ownership in the form of a photo identification card and a utility bill. Permits are limited to one per resident or business and one vehicle per resident or business. A \$25.00 registration fee is required each year to obtain a permit.

Percent of Incident Responses by Incident Type





ORDINANCE NO. 2024-02 BOROUGH OF WEST CONSHOHOCKEN MONTGOMERY COUNTY, PENNSYLVANIA

AN ORDINANCE OF THE BOROUGH OF WEST CONSHOHOCKEN, MONTGOMERY COUNTY, PENNSYLVANIA, VACATING AN UNIMPROVED AND UNOPENED PORTION OF MERION AVENUE, WHICH TERMINATES THE PUBLIC RIGHT TO SAID PORTION, AND PROVIDES THE PROPERTY RIGHTS OF THE VACATED PORTION TO THE ABUTTING PROPERTY OWNERS, PURSUANT TO SECTIONS 1731 AND 1732 OF THE BOROUGH CODE

RECITALS

WHEREAS, the Pennsylvania Borough Code authorizes the Council of the Borough of West Conshohocken ("Council") to make, amend, and adopt ordinances that are consistent with the constitution and laws of the Commonwealth when necessary for the proper management, care and control of the Borough and the maintenance of peace, good government, health and welfare of the Borough of West Conshohocken ("Borough") and its citizens;

WHEREAS, the Borough Code, 8 Pa. C.S.A. § 1731 et seq., authorizes Council to vacate a portion of a street, thereby terminating the public right in or to the portion of the street, upon petition by any person or persons constituting a majority in number and interest of the owners of the real estate abutting the street or portion of the street in question;

WHEREAS, Jeffrey M. Stanley and Elizabeth A. Stanley ("Petitioners") submitted a Petition to Vacate a Portion of Merion Avenue ("Petition"), pursuant to Section 1732 of the Borough Code;

WHEREAS, Petitioners constitute 100% of the ownership of the real estate abutting that portion of Merion Avenue which Petitioners are requesting to be vacated;

WHEREAS, the requested portion of Merion Avenue to be vacated consists of approximately 6,146 square feet, more or less, and is an unimproved and previously laid out, but unopened, portion of Merion Avenue;

WHEREAS, Council has met the procedural requirements of the Borough Code for the adoption of the proposed ordinance, including advertising and holding a public hearing;

WHEREAS, Council, after due consideration of the proposed ordinance at a duly advertised public hearing, has determined that the health, safety and general welfare of the residents of the Borough of West Conshohocken will be served by this ordinance.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Council of the Borough of West Conshohocken, Montgomery County, Pennsylvania, it is hereby ordained and enacted by the authority of the same, as follows:

§I. <u>RECITALS</u>.

The recitals stated above are incorporated herein as if set forth in full,

§II. VACATION OF A PORTION OF MERION AVENUE.

That unimproved and unopened portion of Merion Avenue in the Borough of West Conshohocken consisting of approximately 6,146 square feet, as more fully described in the legal description prepared by OTM, LLC, attached hereto and made a part hereof as Exhibit "A" ("Legal Description"), and depicted on the plan prepared by OTM, LLC, dated August 23, 2023, attached hereto and incorporated herein as Exhibit "B" ("Plan") ("Vacated Portion"), is hereby vacated as a public street, and the public right in or to the street is thereby terminated. Petitioners hereby acquire the rights to the Vacated Portion, which portion is incorporated into the following parcels: 24-00-01896-00-6 and 24-00-01840-00-8.

ŞIII. RELEASE.

Petitioners release the Borough of and from any and all liability, responsibility or damages from the vacating of the Vacated Portion, pursuant to Section 1732(c) of the Borough Code.

§IV. REPEALER.

All ordinances or parts of ordinances which are inconsistent herewith are hereby repealed, it being understood and intended that all ordinances within the Code of the Borough of West Conshohocken, such as are not otherwise specifically in conflict or inconsistent with this ordinance, shall remain in full force and effect, the same being reaffirmed hereby.

§V. <u>REVISIONS</u>.

The Council of the Borough of West Conshohocken does hereby reserve the right, from time to time, to adopt modifications of, supplements to, or amendments of its ordinances, including this provision.

§VI. <u>SEVERABILITY</u>.

If any section, subsection, sentence, clause, phrase, or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such provisions shall be separate, distinct and independent, and such holding shall not affect the validity of the remaining portions of this ordinance.

§VII. FAILURE TO ENFORCE NOT A WAIVER.

The failure of the Borough to enforce any provision of this ordinance shall not constitute a waiver by the Borough of its rights of future enforcement hereunder.

§VIII. EFFECTIVE DATE.

This ordinance shall become effective immediately upon its enactment.

§IX. ENACTMENT.

Under the authority conferred by the Borough Code and other relevant statutory law, the Council of the Borough of West Conshohocken, Montgomery County, Pennsylvania does hereby enact and ordain this ordinance to the Code of the Borough of West Conshohocken this 12th day of March, 2024.



WHEREAS, the Borough Code authorizes boroughs to enact ordinances prohibiting or regulating the keeping or running at large of pets and other livestock animals;

WHEREAS, Council deems it in the best interest and the general welfare of the residents of the Borough to regulate the keeping of pigs within the Borough;

WHEREAS, Chapter 36-13 of the Code of the Borough of West Conshohocken ("Code") currently prohibits any person or persons, partnership, firm or corporation from keeping any pig or hog at any place within the limits of the Borough;

WHEREAS, Council has met the procedural requirements of the Borough Code for the adoption of the proposed ordinance, including advertising and holding a public hearing; and

WHEREAS, Council, after due consideration of the proposed ordinance at a duly advertised public hearing, has determined that the health, safety and general welfare of the residents of the Borough of West Conshohocken will be served by this ordinance.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Council of the Borough of West Conshohocken, Montgomery County, Pennsylvania, it is hereby ordained and enacted by the authority of the same, as follows:



§I. <u>RECITALS</u>.

The recitals are incorporated herein as if set forth in full.

§II. AMENDMENTS OF THE CODE.

A. Chapter 36 "Animals", Section 1 "Definitions" of the Code of the Borough of West Conshohocken is hereby amended to add the following new definition as follows:

§ 36-1 Definitions.

DOMESTIC PIG

A domesticated, tame swine living in or near the habitations of human beings or by habit of special training in association with human beings.

B. Chapter 36 "Animals", Section 2 "Animal Control Officer" of the Code of the Borough of West Conshohocken is hereby amended to read as follows:

§ 36-2 Animal Control Officer.

The Animal Control Officer for the Borough shall be the Borough Zoning Officer. The Animal Control Officer shall be responsible for enforcing the provisions of this Chapter.

C. Chapter 36 "Animals", Section 13 "Keeping of pigs prohibited" of the Code of the Borough of West Conshohocken is hereby amended to read as follows:

§ 36-13 Keeping of domestic pigs.

The keeping of domestic pigs within the Borough of West Conshohocken shall be permitted only under the following conditions:

- A. Each household, partnership, firm or corporation shall only be permitted to keep one (1) domestic pig.
- B. No household, partnership, firm or corporation shall be permitted to keep a wild pig under any circumstances.
- C. The domestic pig shall not be used for any commercial purposes.
- D. The domestic pig shall be kept inside, and not in a pen, cage, kennel, or other similar outdoor storage shelter outside.
- E. The domestic pig shall be kept on a leash at all times while outside.
- F. The domestic pig shall not be permitted to roam free outside.

- G. The domestic pig shall be fed inside, and no feeding troughs shall be permitted outside.
- H. The owner of domestic pig shall promptly remove and dispose of all feces or waste produced by the domestic pig in a sanitary manner.
- I. The owner of domestic pig shall comply with all federal, state, and local health laws in the care, ownership and control of the domestic pig.
- J. Nothing herein shall be construed to prevent a Planned Community / Homeowners Association or Condominium Association ("Association") from establishing rules and regulations prohibiting the keeping of pigs within the Association within the Borough.
- K. Any person violating the provisions of this section shall be subject to the fines and penalties as provided in § 36-18.

ŞIII. <u>REPEALER</u>.

All ordinances or parts of ordinances which are inconsistent herewith are hereby repealed, it being understood and intended that all ordinances within the Code of the Borough of West Conshohocken, such as are not otherwise specifically in conflict or inconsistent with this ordinance, shall remain in full force and effect, the same being reaffirmed hereby.

§IV. REVISIONS.

The Council of the Borough of West Conshohocken does hereby reserve the right, from time to time, to adopt modifications of, supplements to, or amendments of its ordinances, including this provision.

§V. SEVERABILITY.

If any section, subsection, sentence, clause, phrase, or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such provisions shall be separate, distinct and independent, and such holding shall not affect the validity of the remaining portions of this ordinance.

§VI. FAILURE TO ENFORCE NOT A WAIVER.

The failure of the Borough to enforce any provision of this ordinance shall not constitute a waiver by the Borough of its rights of future enforcement hereunder.

§VII. EFFECTIVE DATE.

This ordinance shall take effect immediately upon its enactment.

RESOLUTION NO. 2024-03 BOROUGH OF WEST CONSHOHOCKEN MONTGOMERY COUNTY, PENNSYLVANIA

A RESOLUTION OF THE BOROUGH OF WEST CONSHOHOCKEN, MONTGOMERY COUNTY, PENNSYLVANIA, APPOINTING THE INITIAL MEMBERS TO THE INTERNATIONAL FIRE CODE BOARD OF APPEALS OF THE BOROUGH OF WEST CONSHOHOCKEN

WHEREAS, the Council of the Borough of West Conshohocken ("Council") adopted the *International Fire Code*, as amended ("Code") by way of Ordinance for the purpose of regulating, governing, and setting applicable standards with respect to construction and fire safety within the Borough of West Conshohocken ("Borough");

WHEREAS, the Code provides that an International Fire Code Board of Appeals ("Board") within the Borough shall hear and decide appeals of orders, decisions, or determinations made by the Borough Fire Code Official relative to the application and interpretation of the Code;

WHEREAS, pursuant to the Code, the Board shall be appointed by Council, and consist of five (5) voting members having the qualifications established by the Code, and after the initial terms expire, members shall be appointed for terms of four (4) years, and no member shall be reappointed to serve more than two (2) consecutive full terms;

WHEREAS, Council now desires to appoint the initial members to the Board.

NOW THEREFORE, BE IT RESOLVED by the Council of the Borough of West Conshohocken, Montgomery County, Pennsylvania, that the following individuals are appointed to the Board for the following terms:

- 1. <u>Albert M. Comly, Jr.</u> is appointed to serve as a Board member for a term of three (3) years until 2027;
- 2. <u>Daniel Hinkle</u> is appointed to serve as a Board member for a term of two (2) years until 2026;
- 3. <u>Stephen McManus</u> is appointed to serve as a Board member for a term of two (2) years until 2026;
- 4. <u>Jason Scholl</u> is appointed to serve as a Board member for a term of one (1) year until 2025;
- 5. <u>Herron Duke</u> is appointed to serve as a Board member for a term of one (1) year until 2025.
