Mr. Khal Hassan had two items requests this evening:

1. Council shall evaluate and take action of the defining scope for the RFQ to hire a planner for the overlay district. Mr. Hassan indicated that this is for the scope defining to be explored. It will take several months to prepare the scope and then several months to secure the appropriate planner. This will be brought before the Open Space Committee as well as the Planning Commission. No questions or comments were presented. Mr. Blumenthal asked for a motion.

Police Officer Brandon Rucker was sworn in by Mayor Fournier and congratulated by members of Council and public.

2. Council shall evaluate and take potential action on the recommendation of the Civil Service Commission to fill the vacancy in the West Conshohocken Police Department.

Interim Chief Carfagno highlighted the Civil Service Commission meeting and indicated that there were four individuals. Elizabeth Moran has scored the highest. No questions or comments were presented. Ms. Moran finished the Academy on June 12th. Mr. Blumenthal asked for a motion to hire Elizabeth Moran as per Interim Chief Carfagno's recommendation.

3. Council shall evaluate and discuss taking potential action approving the Police Department to begin the process of conduction a promotional exam for four (4) Corporal to fill the upcoming vacant supervisor positions. These promotions would not take effect until January of 2025.

Chief Carfagno indicated that one Sargent will be leaving at the end of this year and they would like to promote Corporals with a 5% increase starting in 2025. If this passes before Council, 4 officers will be eligible and in the long run this will reduce pay by 5% and provides different structure. Aspirant Group will complete this at a cost of approximately \$1,000 per officer. Jeff Ewing indicated that this has been discussed in public safety and agrees that this provides growth

GENERAL PUBLIC COMMENT

Walter Gleba, resident, commented on the Air BNB situation and read the West Conshohocken Borough Ordinance and wanted to address a letter from Obermeyer and indicated that short terms rentals can be made illegal by municipalities. Mr. Blumenthal indicated that our solicitor would review and thanked Mr. Gleba for the literature he provided.

Christine Corazza, resident, indicated that there is a possibility of 14 homes in the Borough that are being advertised as BNB. She has had countless encounters with the unruly people living specifically on Ford Street which has caused a disturbance with her and other residents. Mrs. Corazza was advised that the police need to be contacted when these incidents are occurring.

Lisa Stiefel, resident, has had an Air BNB next door to her for the last 5 years. At times she has noticed parties, attempted thefts of her personal property and unsafe with the thought of retaliation if she contacted the police for disturbance calls. Mr. Stiefel feels that the Borough is loosing money and rental applications and EIT forms are not submitted and strongly wishes that the Borough would prevent these short term rentals

EXECUTIVE SESSION

Mr. Blumenthal indicated that members of Council will move into an Executive Session to discuss personnel matters and will not be returning as there is no action being taken.

II. COMMITTEE REPORT:

Public Comment on Agenda Items

Mr Gleba - EVCS require a lot of infrastructure considerations, fees and payments for charging, chargers have various speeds and options to consider, parking and traffic issues can be created with long charging times.

Fire Marshall: got all inspection reports back except 5 Tower Bridge and the Marriott, will send all to Fire Department when completed. 4 Tower Bridge and 1K1 have active permits out now.

Code Inspector: Working on rentals, have a few left. Remaining will be cited soon for not having rental licenses. Updates on residential building codes seminar in August.

Solicitor's Report: Proposed draft ordinances (neither viewed or approved by council, just out for public comment and drafting at this point)

- Repair of Motor Vehicles (7B) adding a new chapter to code or ordinances to regulate repair of motor vehicles done on borough streets and sidewalks
- Does not currently address the ability/responsibility to tow vehicles if they have become disabled on a sidewalk or borough street due to repairs, can we add that in addition to the ability to fine/jail?
 - Mr. Dennis Frankenfield maybe putting in a time frame to do the repairs, if it's not something you can do in a minimal amount of time noted in the emergency piece of the ordinance for example, it's not something that should be done on a public street. Maybe in

that case you notify the police or borough so they know the repair is going on and can be monitored for completion.

- Mr. Davis recently received a mobile tire service to change his tires, met at a safe location but the change wasn't able to be done properly, left it on Summerwood until it was able to be repaired. Can we address parking lots that are/are not available for use for this location? Mobile repair services can they be looked at?
- Ms. Scarlett if the repair cannot be done quickly in the event of a breakdown, the ordinance should focus more on what services need to be done to get the car moved so that repairs can be done in a proper location. Refer to the Philly ordinance for ideas.
- Ms. Malecky auto repair property on Bullock/Cedar three vehicles flagged for towing due to abandonment there but nothing has been towed. (Chief Carfagno tagged and notification process for 7 days is the law, can't move it before that. Must be unregistered or disabled to qualify.) Can we add that ability to any of our ordinances, select ability of towing companies to do that? Is there a rule that that block of Bullock is allowed to have double sided parking even though nowhere else seems allowed on the street? Also, there were public disturbance issues there on Fourth of July, drinking publicly, not sure what else is going on but seems unsafe. (Solicitor: parking decisions, any side of street, created by ordinance only and would need to be a separate ordinance)
- Chief Carfagno if we're going to fine people for violating this ordinance, we need to be able to prove it in court, so a time limit may be difficult since the police won't be notified during start/stop.
- EV Ordinance (7A) sets language and requirements for charging stations, amendment to the zoning chapter 113, especially looking for input from any professional staff and fire department
 - Not a retroactive ordinance, only covers going forward
 - -Mr. Dave Frankenfield not sure if it belongs in the zoning code, also feels this would be difficult to enforce. Concerned about potential for EV charging stations in the flood zone. Liked the language about the disconnect stations, glad we took input from the fire department's concerns in the creation of this code.
 - -Mr. Davis For commercial purposes, seems like chargers should be linked to an activity (i.e. going to work or going to stay at the Marriott), on borough property it may not make sense because they shouldn't be parking there for a long period of time if not linked to an activity.
 - -Mr. Gleba: state of the art stations now can do a charge in 30 minutes. The best way to put out an EV fire is using a blanket/smothering the fire, that technology should be invested in. Need to consider theft (of cords, plugs), trash, by EV charging stations which may put strain on our police department or public works. Residential stations seem much better than investing in these on borough property. If someone is just going to stop by for 30 minutes, where are they going to use the bathroom, etc.

Police Department:

Always call if something is wrong, in the moment. Example: traffic issue, noise violation, public disturbances, etc. Call the station for non-emergency, 911 for emergency.

- Tuesday, August 6 at 6pm Mackenzie Park for National NIght Out, \$6,000 in donations from West Conshy and Conshy businesses not including the bicycle giveaway
- Planning the 5k again for this year, hopefully early October
- Elizabeth Moran newest officer, hoping to swear her in next council meeting

George Clay Fire Company:

- Blood Drive on 7/12 26 units were donated
- Next Blood Drive 9/20, looking for community support
- Ladies' Auxiliary August 18 back to school event at 12pm for school supply giveaway, will be hoping to recruit future firefighters at this event as well. The community can contact the fire department to donate
- Will be at National Night Out 8/6 with police department
- West Conshy was relatively lucky with the recent storms, minor cleanup and outages

Public Comment:

- Mr. Dennis Frankenfield just wanted to confirm that the Borough Engineer was involved with the draft ordinances (he was). Would like to put the smothering blankets into the upcoming budget. Heavy metals emitted from vehicle fires could damage structures in addition to fire alone. Church/Ford to Matsonford could we do a traffic study at that intersection to see if a light would be needed? It was something that was discussed in the past
- Mr. Gleba August 17 Community Day at Mackenzie Park 12-4pm
- Ms. Malecky wanted to commend the police for presence at Church/Bullock for running stop signs, has curbed a lot of the issue. Is there any way we could change the speed limit on Ford Street, especially in the mornings it seems dangerous with the cut through traffic.
- Mr. Williams Moorehead/Elizabeth intersection how can we slow cars going through that way, could it be made into a corner? It seems to be a safety concern with almost a blind curve through the stop sign. Is there a solution?

Candlelight Vigil September 11th 7pm



Digital Ticket Devices

License Plate Readers were installed and located in multiple locations throughout the Borough of West Conshohocken. Officers can access and view these readers through multiple devices to assist with traffic enforcement and investigations.

FLEET MANAGEMENT

Police Vehicles

Fleet Management Officers maintain all Police vehicle maintenance records. Records are stored in the Departments web based Fleet Management / GPS System. The system alerts Officers of upcoming scheduled maintenance for all of the Department's vehicles. *(Vehicle mileage, warranties & conditions attached)

All the Department's patrol vehicles have had decals and equipment completely restored and updated to prolong their usage.

Traffic

The Police Department continues monitoring all of the Borough's traffic areas and any requests by residents for problem traffic areas. Officers conduct multiple traffic details daily throughout the Borough. Please contact the Police Department to report any traffic complaints or concerns.

Permit Parking

Parking permits, renewals or replacement tags are available for purchase or replacement at the West Conshohocken Police Department, Monday through Friday between 8:00am-4:00pm. Applicants must be a resident or business owner, must provide proof of residence or business ownership in the form of a photo identification card and a utility bill. Permits are limited to one per resident or business and one vehicle per resident or business. A \$25.00 registration fee is required each year to obtain a permit.

Any vehicles that park in the Merion Avenue permit parking lot without a valid 2024 permit parking tag assigned to a specific registration is subject to a \$50.00 fine.

Officers monitor, enforce and conduct parking details daily, including the permit parking lot. Please contact the Police Department to report any parking complaints, issues or concerns.






Count of Incidents by District

RESOLUTION NO. 2024-15 BOROUGH OF WEST CONSHOHOCKEN MONTGOMERY COUNTY, PENNSYLVANIA

A RESOLUTION OF THE BOROUGH OF WEST CONSHOHOCKEN, MONTGOMERY COUNTY, PENNSYLVANIA AUTHORIZING, EMPOWERING AND DIRECTING THE APPOINTMENT OF AUTHORIZED REPRESENTATIVES OF THE BOROUGH FOR THE EXPRESS PURPOSE OF SHARING CONFIDENTIAL TAX INFORMATION FOR OFFICIAL TAX COLLECTION REASONS WITH BERKHEIMER, THE APPOINTED EARNED INCOME TAX COLLECTOR FOR THE BOROUGH

WHEREAS, The Local Tax Enabling Act, Act of December 31, 1965, P.L. 1257, No. 511, as amended ("Act 511"), authorizes the Borough of West Conshohocken ("Borough") to engage and compensate third parties for the collection of taxes authorized under Act 511;

WHEREAS, the Borough has contracted with Berkheimer of Bangor, Pennsylvania ("Berkheimer"), to collect its earned income tax;

WHEREAS, Act 511 mandates that any information gained by the appointed tax officer, its agents or by any other official or agent of the taxing district, as a result of any declarations, returns, investigations, hearings or verifications required or authorized by the taxing municipality's ordinance, be kept confidential, except for official purposes;

WHEREAS, Berkheimer requires passage of a resolution regarding the release of confidential information to it, in its tax collecting capacity.

NOW THEREFORE, BE IT RESOLVED by the Council of the Borough of the West Conshohocken as follows:

- 1. - 2. Berkheimer is hereby authorized, directed, and empowered to provide and/or transmit any and all tax information and records, or any portion thereof, relating to the collection of taxes for the Borough to Doug Borgerson and Meg Decker as the authorized representatives of the Borough.
- 3. The Borough hereby holds harmless, indemnifies and/or absolves Berkheimer from and against any and all liability in connection with the release of said confidential information, provided any such liability is not caused by the malfeasance or gross negligence of Berkheimer.
